RE: Regular Village Board Meeting Agenda Item - June 20, 2005

The Board agenda for June 20 includes an item regarding "Request to amend the code for gambling machines." Attorney Curtis who represents The Village Inn and the Legion Post requested that this be on the agenda. A petition has been forwarded to the Board in a previous packet requesting a change in the ordinance to allow video machines in taverns pursuant to a recent change in the City of Brookfield ordinance.

As you may recall, the Board had previously rejected such a request. The petition asked that the Board consider the change again. Attorney Pollen will staff this request. Although the Board could take action on this Monday evening, it may be more effectively discussed at the committee level.
